‘We worked with excellent forms, but these were part of a rather inefficient and manual work process,’ says Wouter Vosse, partner of Hamelink & Van den Tooren, about the reason for implementing RegLab’s AML solution. Stacks of files

The Hamelink & Van den Tooren office worked in an old-fashioned, manual way to onboard new clients. Various forms were used to comply with the AML guidelines. These were sent to clients and then scanned and stored. This resulted in an inefficient work process. The aim of the office was to modernise the working method in such a way that working according to AML guidelines was facilitated, for both employees and clients.

No room for mistakes
